### 1. What information we collect, use, and why

#### 2. Lawful bases

Our lawful bases for collecting or using personal information to provide services and goods are:

- Consent
- Legitimate interest:
  - We provide funding for safety equipment for people living with epilepsy and bereavement support. We need health information to confirm the need for the equipment ensure the equipment is going to be effective for the type of seizure confirm the need for bereavement counselling
  - We need the address of the recipient so that we can order the equipment and have it delivered directly to them. We can recruit bereavement counselling services in the locality of the applicant. We can source appropriate therapies if counselling is not the preferred option.

Our lawful bases for collecting or using personal information for research or archiving purposes are:

- Consent
- Legitimate interest:
  - We collect and use personal information for evidence to build evidence for applications for grants and funding vital for us to continue our work with young people. This information will include location, (County), age of the user, type of equipment provided, and / or support offered to bereaved siblings and close friends.
  - We use feedback and photographs provided by the family of the recipient to promote our charity and the support we provide and reach other potential beneficiaries.

### 3. Where we get personal information from

- People directly
- Health care providers

### 4. How long we keep information

i. We keep information including name, address, phone number and email address and equipment provided for 1 year from dispatch of equipment. If there is an ongoing package of support we may retain your information for a longer time, appropriate to the need for involvement.

ii. We keep your email address to continue providing quarterly newsletters until you withdraw consent. We will check at a reasonably regular period that you wish to continue to receive the updates.

iii. We keep a first name, age, county and type of equipment provided to build a record of trends and data on demographic and location of support. The information used in these reports will not identify you individually.

## 5. Who we share information with

Others we share personal information with

- Other relevant third parties:
  - We provide names, addresses and contact details of our applicants to suppliers of safety equipment for ordering and delivery purposes.
  - We provide names addresses, contact details and basic details of the bereavement of the applicant, to enable them to take over the support of the young person in question and maintain contact with the family directly.
  - We share feedback and photographs provided by families on our website and social media, including Facebook, Instagram, X (formerly twitter) with the consent of the providers. \*See note on your right to erasure and your right to withdraw consent.

## 6. Your data protection rights

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal data.

**Your right to rectification** - You have the right to ask us to rectify personal data you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

**Your right to erasure** - You have the right to ask us to erase your personal data in certain circumstances. \* *Although we will remove your feedback and photographs from our website, and our pages on social media, we cannot guarantee total removal from all other pages. (i.e we cannot erase feedback and photographs which may have been shared by your contacts or their contacts)* 

**Your right to restriction of processing** - You have the right to ask us to restrict the processing of your personal data in certain circumstances.

**Your right to object to processing** - You have the right to object to the processing of your personal data in certain circumstances.

**Your right to data portability** - You have the right to ask that we transfer the personal data you gave us to another organisation, or to you, in certain circumstances.

**Your right to withdraw consent** – When we use consent as our lawful basis you have the right to withdraw your consent. \* *Although we will remove your feedback and photographs from our website, and our pages on social media, we cannot guarantee total removal from all other pages. (i.e we cannot erase feedback and photographs which may have been shared by your contacts or their contacts)*
